

Buckingham Slate Photo Contest General Agreement & Disclaimer

Rules

- Submissions may be entered online **ONLY** via the Buckingham Slate website.
- Submissions must be for hardscape or architectural project utilizing Buckingham Slate products.
- Only projects completed within the last 12 months will be considered.

Submissions are evaluated on the following:

- General Project Aesthetics
- Colors And Patterns
- Unique Use Of Buckingham Slate Product(s) – **Hardscapes** – Slate mulch, landscaping boulders and slabs, Flagstone: Pathway, Irregular, Dimensional
Architectural – Walls, Columns and Caps, Exterior and Interior Flooring, Custom Uses (mantels, counters, windowsills, etc.)
- If Buckingham Slate does not hear back from the winner within two (2) days, Buckingham Slate will call the winner and send a follow-up email. If there has been no response from the winner within three (3) days of the initial email, a new winner will be selected and notified.

General Agreement

- Contest entrants agree to abide by the terms of these Official Rules and by the decisions of the judging organization, which are final on all matters pertaining to contests. The return of any prize/prize notification as undeliverable may result in disqualification and selection of an alternate winner.

Additionally, I waive any right to royalties or other compensation arising or related to the use of the photograph. I hereby hold harmless and release and forever discharge Buckingham Slate from all claims, demands, and causes of action which I, my heirs, representatives, executors, administrators, the entity I represent, any agents thereof or any other persons acting on my behalf, on behalf of my estate, or on behalf of the entity I represent have or may have by reason of this authorization.
